## PROGRAM APPLICATION NEW HOME PURCHASE ASSISTANCE GRANT

FOR NEWLY CONSTRUCTED, OWNER OCCUPIED RESIDENTIAL PROPERTY ONLY

The Lawrenceburg Redevelopment Commission has instituted a purchase assistance grant program for individuals purchasing a newly constructed residential unit located within downtown Lawrenceburg. The program is administered by Lawrenceburg Main Street Inc.

**PURPOSE:** The goal of the program is to encourage downtown residency areas by improving the inventory of housing available in that area.

**GRANT AMOUNTS:** Eligible applicants may receive a grant equal to 10% of the purchase price of the residential unit up to a maximum amount of \$35,000. Value to be determined by a licensed, outside third party appraiser, with no connection to either the buyer or seller.

**QUALIFICATIONS:** To qualify, the following requirements must be met:

- The residential unit must be newly constructed, owner occupied and located in downtown Lawrenceburg.
- The buyer must agree to occupy the home as a single family residence for a minimum of three years.
- The buyer must pay cash or acquire financing through a bank, savings and loan or mortgage financing institution of their choice. Land contracts will not qualify and private financing will have to be thoroughly reviewed before approval.

ADMINISTRATION OF GRANT: Grants will be administered by Lawrenceburg Main Street, subject to terms dictated by the Lawrenceburg Redevelopment Commission. When the buyer has obtained mortgage financing, grant funds will be presented at the closing. In the case of cash purchases, grant funds will be released when a certificate of occupancy has been issued and final payment is being made to the builder. If the buyer has secured a construction loan, the funds will be presented at the closing of the construction loan, to the lender, to be held in escrow for the buyer. Grant funds may be presented as an electronic transfer or as a check in which case, the check may be made out to one or more recipients as is appropriate for the circumstances. The Lawrenceburg Redevelopment Commission and Lawrenceburg Main Street Inc. reserve the right to make

adjustments to the manner in which a grant is administered when necessary and appropriate.
